1.1. <u>Reservation</u> The posts against this quota are opened to all candidates and candidates belonging to SC/ST/OB categories who apply against this quota be extended relaxation in age limit as admissible in general open market recruitment. 2. ELIGIBILITY NORMS :

2.1. Scouting / Guiding Qualifications:

The following qualifications would apply for recruitment of Scouts & Guides to posteviel -1 and Level-2.

- (a) A President Scout/Guide/Rover/Ranger Himalayan Wood Badge (HWB) holder in any section.
- (b) Should have been an active member of a Scouts organization for the last gears. The 'Certificate of Activeness' should be as ptenexure-III: and
 - (c) Should have attended two events at National IOREAll Indian Railways' leveAND Two events at State level

2.2. <u>EducationalQualifications</u>:Candidates should possess requisite academic qualification on the date of submission of application as given below. Those who are appearing at and/or awaiting results of final examination are not eligible:

3.2. Instruction for filling up the application Form:

- (i) The notification with the application form are available in Railway Recruitment Cell (RRC) Bhubaneswar's website www.rrcbbs.org.irCandidates should carefully read the instructions before filling up application form. Application Form should be made on a good quality white A -4 (210x297 mm) size paper using ONE SIDE ONLY. The candidate should use the same format as available in the website.
- (ii) The candidate has to fill up required information in his/her own handwriting using blue / black ball point pen. The application should be filled either in English or Hindi but not in any other language. Application filled in any language other than Hindi/English and having any change in the format of application will lead to rejection of application summarily.
- (iii) One recent passport size photograph (4cm x 5cm) should be affixed on the application form without fail. The Photo may preferably be not older than 3 month as on date of applying. The photo should clearly reveal the full face and should be taken without wearing cap and goggles/coloured glasses. Photo should be new, sharp and clear, with light background, suitable for scanning and printing. Do not put any mark or signature on the front side of the affixed photograph. The photograph should be neatly and firmly pasted in the prescribed space, and not stapled or pir **Pledtograph should not be attested**
- (iv) One loose extra photograph with name, date of birth, and signature of the candidate written on the backside should be attached along with the application form.
- (v) Candidate should copy the paragraph at Item-25 of the application form in English/Hindi in his/her own running handwriting (not in capital/spaced out letters) in the space given below the paragraph.
- (vi) Signature of the applicant must be full and in running <u>hapted in block capital letter</u> disjointed letters. Candidates are required to sign in English or in Hindi in the prescribed places provided in the application form.
- (vii) While filling up of the application, candidates have to ensure that the signatures and two marks of physical identification. Candidates should also give two left thumb impressions in the application form. If the LTIs are not clear and are smudged, the application will be liable to be rejected.
- (viii) Applicant should write on the top of the envelope containing the application as follows <u>Application</u> against Scouts and Guides Quota Recruitment for the year 2024-25 for Group-C or Erstwhile Gr.D.'
- (ix) Applicant should clearly indicate the post for which he/she applied for (i.e. for Group-C or for Erstwhile Gr.D). Applications without indicating the post will be rejected.
- (x) Candidates should send their applications so as to reach at the address mentioned at para 3.3 below on or before the closing date and time. Railway Administration shall not be responsible for any postal delays. Application received after the last date & time would be summarily rejected.
- (xi) Candidates should note that only Date of Birth as recorded in the Matriculation/High School Examination Certificate is to be considered.
- (xii) Candidate should write his/her name, father's name / husband's name in capital letters as given in educational Certificate.
- (xiii) Before applying for a post, the candidate should ensure that he/she fulfils the eligibility and other criteria stipulated for the post. The Railway Administration would be free to reject any application not fulfilling the requisite criteria at any stage of recruitment and if erroneously appointed, such candidate is liable to be summarily removed from service even after appointment.
- (xiv) While filling up the application, candidates serving in any government Department or Public Sector Undertaking including Railways may give a "Declaration" that they have intimated the fact of their

applying for the exam to their office in the event of their selection, they will submit NOC from their employer at the time of Document Verification. In case they fail to submit NOC at the time of Document Verification, their candidature would be cancelled.

- (xv) Those candidates who are debarred from appearing in any of the RRB/RRC exams need not apply unless their debarment period is over by the closing date of this Employment Notification. Otherwise, their applications shall not be entertained.
- (xvi) Applicant should enclose with the application a selection of selection of educational qualification, age, community etc.
- (xvii) Copies of participation certificates and membership certificate for the last five years in the recent past should be enclosed along with the application form.
- (xviii) The continuation certificate as active member should be submitted positively as given in Annexure -III of the Application Form.
- (xix) Applicant should fill all the columns in the application without fail.

This will be further subject to condition that such candidates should secure minimum 35% marks in the Written Test, The merit list of Written Test shall be criterion for short listing of the candidates for document verification (DV).
